PARCC Testing

During the month of April, all students in grades 3, 4, and 5 will be tested in the areas of reading and mathematics. It is extremely important that students be in attendance to take the tests! The results will be sent to a scoring firm contracted by the State of Illinois Board of Education. The results will be shared with parents when we receive them. Please encourage your child to do her/his best. How our children do on this assessment does reflect on our community and our school district. As with any other school day, please make sure your child gets plenty of sleep and eats a balanced breakfast. Good luck to all our kids and staff! Most teachers will allow students to have gum or hard candy during testing. Please check with your child's teacher before sending

any. Water will not be allowed during the testing time as all testing is done on computers this year.

Online Registration is OPEN and 2017-18 Fees are Online!

Manhattan School District 114 registration will be Online for the 2017-2018 school year. Registration for current and new families will be done at home through your personal computer. This process will result in substantial savings in paper and printing costs for our district and make the registration procedure much more convenient for our families.

We have learned that sometimes Internet Explorer does not always work for registration, as it is not as up to date as it should be. If you encounter this problem, please try registering through Firefox or Google Chrome.

Please login to your Home Logic account and register your students for next year. Fees for the 2017-18 School Year are now on your account. Please login to your account to pay fees for 2017-18 and any outstanding fees.

Student Arrival - Automobile, Bicycles, Walkers

Children walking, riding bicycles, and being dropped off by parents, are not to be on school grounds until after 8:25 a.m. The only exceptions are children attending Rec. Care or children that arrive early due to teacher request. Children are to follow the Rules-of-the-Road regarding bicycle safety. Extra Care must be taken around the school due to the high volume of vehicular traffic. Children walking home are requested to use the sidewalks whenever possible. Students walking home on Second Street east of the school are to walk on the right side of the road.

Dressing for the Weather

For grades one (1) thru five (5) the noon duty supervisors will decide whether or not the students will go outdoors depending upon weather conditions. Dress attire should be appropriate for the weather conditions. These decisions will be at the discretion and judgment of the recess supervisors. Verbal notification from recess supervisors, as well as written notification in newsletters, will be provided to the students and parents, of expectations for the good of the whole student body.

Dear Parent/Guardian:

We appreciate your investment in your child's education and want to share with you some information about state and federally required assessments.

Federal law requires the Illinois State Board of Education (ISBE) to administer certain assessments to **all students** who attend public schools in the state, including students who attend charter schools.

According to federal law:

- Students must take an achievement exam in reading/language arts and mathematics each year from **third through eighth grade**. In Illinois, students take the Partnership for Assessment of Readiness for College and Careers (**PARCC**) exam.
- Students must take an achievement exam in reading/language arts and mathematics once in high school. In Illinois, **high school juniors** take the **SAT**.
- Students must take an achievement exam in science three times from third through 12th grade. In Illinois, students take the **Illinois Science Assessment** in **fifth grade, eighth grade, and after completing Biology I in high school**.
- Students identified as English Learners must take an English language proficiency exam once per year until English proficiency is reached. In Illinois, **English Learners** take **ACCESS**.
- Students with the most severe cognitive disabilities must take alternate assessments in reading/language arts, mathematics, and science. In Illinois, **students with severe cognitive disabilities** take the Dynamic Learning Maps Alternate Assessment (**DLM-AA**).

These are the only ISBE-required student achievement assessments.

Assessments help improve standards, curriculum, and instruction at the classroom, school, district, and state levels. Assessments play a role in helping ISBE and school districts identify areas where schools need targeted support. The average amount of time spent on accountability assessments represents **less than 1 percent of the school year**.

However, we want educators and students to devote as much time as possible to learning, not testing. We are working with districts and schools to evaluate local testing programs and reduce the amount of testing for students, where we can.

We encourage students to do their best on all assessments.

Individual districts and schools may have local policies for students who refuse to take assessments on testing days, but federal and state law does not authorize districts or schools to excuse students from testing. ISBE does not provide guidance on “opting out” because such an option would violate the law.

School districts must administer assessments to at least 95 percent of students and at least 95 percent of each student demographic group or face lower public school recognition status, which leads to increased state oversight and puts districts’ state and federal funds at risk. Individual high school students who had the opportunity to but chose not to take the required state accountability assessments (the SAT and the Illinois Science Assessment) lose their eligibility to receive a regular high school diploma. (Current high school seniors who may not have had the opportunity to take one of the required assessments will not be prevented from receiving a regular diploma.)

We encourage students to complete as much of each assessment as they can. If at any point a student feels they no longer can or wish to continue, they may indicate this to the test administrator.
