BUILDING AND DEVELOPMENT COMMITTEE:

We will be seeking Board approval during regular meeting for the following proposed summer projects. Projects include; parking lot seal coating, painting, concrete sealing, 10-Year Life Safety Review, Anna McDonald chiller unit repair, boiler blow off valves at all locations, reseal pump #10 at Wilson Creek, Wilson Creek roof maintenance, reseal Wilson Creek boiler circulating pump, replace coil on Jr. High Gym Unit, chemical delivery system for Wilson Creek water tower, repaint and refinish the Jr. High gym floor.

Total cost of maintenance work - \$91,215 with the gym floor.

FINANCE AND OPERATIONS COMMITTEE:

The Finance Committee met and discussed the FY17 Tax Levy, the bond & interest abatement, the proposed projects for summer maintenance of the buildings and grounds, and budget projections for FY17. The recommended levy was in the amount of \$9,915,652 at a tax rate of 4.26, which is one cent lower than FY16. The projected budget for FY17 is a balanced budget. It is projected that revenues will increase by 2.9% and expenditures will increase by 4.4%. This includes the increase in salaries, insurance, and the bond & interest payment that increased by \$500,000.
